Additional MDS Services & Solutions

Next Step MDS Coaching Program:

- Proactive MDS coaches provide a proven plan of 1:1 support and oversight for 60 days at a flat monthly project fee. Services include completing or reviewing a sample of MDS assessments alongside the trainee. In addition, direct access to a designated coach for questions, coding help and guidance is available as they hone the skills introduced in orientation. Flat rate Next Step plans start at \$850/month.

MDS Safeguard Partnership:

- Ensure MDS compliance and reimbursement accuracy through remote MDS assessment pre-submission QA audits of Medicare assessments for 90 days. \$850/month for 3-5 monthly audits with detailed reports and monthly consultation sessions.*
